HENRY HAULE'S NOTEBOOK, 1590-95

INTRODUCTION

The Volume 1

This book acquired by the Kent County Council in 1982 is an octavo volume of 177 pp. with the original leather binding and bearing on the second page the legend: *Henrici Hauli Liber*. There is some evidence to suggest that it was originally used for what is possibly a digest of part of Harleian MS 2154, an account of dukes and marquesses created between the reigns of Edward III and Edward VI. Haule then used it for his own purposes, but did not exhaust the pages, and it was again used by George Haule, his son, or possibly his grandson, some forty years later as a diary of recognizances. Analysis is, in fact, somewhat complex and one can identify no fewer than seven elements within the volume. These comprise:

- (a) Receipt of fees, 1590: pp. 3-24;
- (b) Loans, demands and payments, 1590-95: pp. 40-82, 87-107, 109-119;
- (c) Notes regarding Henry Haule's duties at the Middle Temple: pp. 25 (pt), 28, 83-6;
- (d) Notes regarding law suits heard at St. Albans, when the Queen's Bench adjourned there because of the plague; pp. 35-39, reversed;
- (e) Miscellaneous notes, including medicinal recipes, genealogical information and matters concerning lands near St. Anne's Chapel, Maidstone: pp. 1, 2, 108-9, 117 (pt), 128;
- (f) Diary of recognizances kept by George Haule, 1644-50: pp. 25 (pt), 28-34, 129-177;
- (g) Notes in an unknown hand regarding the creation of dukes and marquesses *temp*. Edward III to *temp*. Edward VI, sixteenth century: pp. 119-26 reversed.

Sections (b) and (e) are compiled in various hands, not all identifiable, though the greater part of the first five elements can be directly attributed to Henry Haule and the whole of section (f) is in the hand of George Haule.

A further complication arises from the indiscriminate use of English, Latin and law French, sometimes all three in one entry, but because most entries are in recognizable form it has seemed right in editing to standardise the whole in English, giving the original form where for some reason this seemed necessary for the sense of the entry or as an illustration of the idiosyncratic approach of the

author. In the case of section (d), the series of law-suits, it has been decided to provide brief notes of the cases indicating where other accounts can be found and not an edited transcript, and section (g), which is irrelevant to the main content of the volume and offers no fresh evidence or information worthy of inclusion, has likewise been omitted except for a brief note.

The Authors

Henry Haule, 155?-1622, came of a well established Wye family, known in medieval times as 'de Aula'. He was the son of the union of George Haule and Joan Bourne and was admitted to the Middle Temple in 1571. Subsequently, in 1578 he was called to the Bench, became a Bencher in 1595 and Treasurer in 1606. More significant for the purpose of these accounts he was Reader (i.e. lecturer in law) at the Middle Temple in 1595 and again in 1601. He appears to have married twice, but of his first wife Dorothy we know nothing. In 1585, however, he married Jane, sister of Anthony Dering the father of Sir Edward, the antiquary. Jane Dering and Henry Haule had at least four children, but the only survivor was the fourth son, George, born in 1591, the year of his grandfather's death, and the probable compiler of the later section of this volume, ⁴ although Henry's will refers to a younger son Henry as well. ⁵

By 1590, Haule was well established as an attorney with a practice extending over mid and west Kent and with connections with many of the gentle families of that area. Just when he moved from Wye to Maidstone is uncertain, but by the time this volume was in use his interests indicate a close association with the county town. In the pursuit of his profession he obtained some degree of control of Boley Hill House, Rochester, 6 and by 1597 is said to have held it, and in 1598 he became a trustee of the Will of John Amies, which included a benefaction to the poor of Wye. 7 Before the end of the century he had acquired Digons in Maidstone from the Barham family. 8 His name first appears on the Commission of the Peace for Kent in 16059 and five years later he and William Gull were responsible for establishing a House of Correction in Maidstone. 10 He was certainly present at the Maidstone Burghmotes from 1612 and when he died, in 1622, his will recorded benefactions to the poor of Maidstone and of Wye. It was during this later period, too, that he built up his estate in Maidstone, largely from the Barham family and including the mansion of Chillington House, now the core of Maidstone Museum. 11 He also acquired an interest in St. Faith's churchyard and in St. Anne's chapel at Maidstone, the former leading to repeated disputes with the borough, both during his life and that of his son. 12

It is hardly surprising that, with his close family association with the Derings, Haule should have been attracted to puritanism. He had family or business connections with the Twysdens, Knatchbulls and Scotts and his concern with the trusteeship of wills leaving bequests to the poor was another indication of this religious link and, according to Peter Clark, he not only suffered by reason of his radical outlook, but also spent much time preparing wills for ordinary people and advising parishioners how to prosecute their incumbents! 13

Of George Haule we know far less and some confusion arises because there appears to have been a son, another George, who died two years before his father. The diary of recognizances as we have it ends abruptly in 1650 the year of the death of the younger man and while Hasted refers to George as Henry's son, Russell considered that the J.P. was the grandson. ¹⁴ Nothing in the book




Fig. 2. The arms of Haule, as drawn by Sir Edward Dering in his *Kentish Armorial*, 1625-1677. (This figure has been kindly provided by Mr. Philip Blake, who has contributed the following note:

elucidates this problem. The elder of the two men, if indeed Russell is right and there were both father and son, was certainly a lawyer like Henry and was admitted to the Middle Temple in 1614 at the age of twenty-three. ¹⁵ He first appears in the Commission of the Peace in 1644 which would tally with the beginning of the entries in the diary, but it is not possible to say with certainty that this is the same man as the member of the Middle Temple. ¹⁶ On the other hand, we do know that George was a puritan, like his father, and that he was an associate of Caleb Bankes of Maidstone, the two of them falling foul of the Privy Council in 1634. ¹⁷ He was among those who supported Dering's candidature for the Long Parliament in 1640. George Haule married Elizabeth Duke who died in 1663 and they were outlived by a daughter, also Elizabeth, who after her father's death in 1652, sold Chillington Manor to a member of the Beal family. ¹⁸

Henry Haule's Accounts

It has already been indicated that the notes kept by Henry Haule fall into four different categories: fees received; payments, loans, bonds, etc.; information regarding his readership at the Middle Temple; and various notes of medicines or concerning property or family affairs. The first and second of these can be clearly distinguished, but the other two can only be noted as they occur among the two main sections. In this introduction, however, each part is considered independently.

(i) Receipts of Fees

These entries, which cover the period 1590-95 and appear on pp. 3-24 of the accounts, indicate associations with two different groups of people: other members of the legal profession and the lesser gentry of Kent and East Sussex, including many persons related to the Haule family. Most of the entries give the name of the person concerned but no detail of the cause, so that it is not possible to interpret fully the limited information given. One can judge that Haule was acting on a regular basis as legal adviser or agent for members of the Dering, Knatchbull, Scott, Twysden, Broadnax, Swann, Kempe and Delahaye families. The Dean and Chapter of Rochester retained his services and among other well known Kentish names are found Epps and Edolphe, both noted within the Cinque Ports at that date and also William Heblethwayte, town clerk of New Romney. 19 It is also apparent from these entries that Haule was involved in litigation in the Courts of King's Bench, Exchequer and Chancery and also those of Requests, Wards and Liveries and, occasionally, Star Chamber. At the local level the Assizes are his business and from time to time he appears in the courts for Maidstone, Wye and Dymchurch (this last presumably for the Liberty of Romney Marsh).

(ii) Payments, loans, etc.

This second element of the accounts is very much more complex than the first and must be dealt with in far greater detail because, although Haule is primarily an attorney, he is plainly involved in numerous financial transactions some of which are of considerable interest. First of all, of course, he is concerned in the payment of fees in the courts for litigation in which he is involved. Presumably

these payments were recouped from the litigants, but it is evident that sometimes considerable periods of time passed before accounts were rendered and with the Knatchbull family, for example, there appear to be periodic settlements. One can follow the various stages of a case through one of the courts of equity with the fees for answers, demurrers, interrogatories and other elements of the legal process being given. Then, too, there are payments made by, or to, Haule for rents and in the case of William Henmarshe it would seem that he is paying out a legacy for the sustenance of children for whom Henmarshe is guardian. A similar instance occurs with Robert Honeywood and with regular payments for his sister, Morton's family. One law suit, which apparently lasts throughout the period of the accounts, concerns Haule's sister, Margaret Wevell, and her brother-in-law John Weyell, but although the references are frequent there is no indication of the cause or of the background of the case. 20 Likewise there are a few indications that Haule is concerned with conveyancing matters and he seems to have some degree of responsibility for paying the stipend due to the curate of Wye. In all these matters, of course, Henry Haule is acting as one would expect from a lawyer of the period and there is nothing exceptional in these entries.

On the other hand on numerous occasions he is involved in the advancing of small loans, varying from a few pence, e.g. 2s. 6d. to Mr Tyser, to as much as 20li. to a member of the Colepeper family. On one such occasion he notes that two leases were left in pawn against a loan of 40s. and in the majority of cases such loans are noted as repaid and the entry is struck through. The settlement of all these loans is either to be 'at sight' or at a specific date, usually very short term, and there is no indication that any interest is being charged. These entries are often written in the hand of the borrower and his signature is appended to the entry and are therefore in the form of promissory notes. In all at least thirty clients are involved in this manner and about seventy such loans are spread fairly evenly over the period covered, the annual total varying from just over 40li. in 1592/3 to 100li. in 1594/5.

On a few occasions Haule, himself, obtains similar small loans, possibly an indication that he, too, despite regular fees was sometimes short of ready cash at a time when cash fluidity was a major economic problem.

There are also twenty-five occasions on which Haule enters into bonds for larger sums of money. Usually he is the second party to the transaction, presumably in the sense of being the security for the person actually requiring the loan. On six occasions, however, he is the sole beneficiary and once 40li. is borrowed on bond from Haule. Otherwise the sums vary considerably from a mere 13li. 10s. 8d. to 400li., but in fifteen of the instances the sum involved is 100li. or more. In two of these cases something rather odd seems to be taking place: on 4th February 1590/1, Robert Honiwood with Henry Haule became bound to Robert Cutte, citizen and ironmonger of London, in 80li. with a condition to pay 60li. at the usual place within the Royal Exchange on 13th May following. At the same time Haule was bound in 100li. to Honiwood with the condition to save and keep him harmless in respect of the obligation to Cutte. Another rather complex transaction occurs in August 1595 when Jeremy Fleete was bound to Haule in 40li. on condition to repay 20li. on 2nd December following. On the same day Haule was also bound together with Samuel Fleete in 201i. to a Mr Cooper with the obligation to pay him 101i. 6s. 8d. on 4th December at the Middle Temple Hall, with the proviso that if Jeremy Fleete pays the 20li. which he owes, then Haule is to pay the 10li. 6s. 8d. to Cooper,

but if Jeremy defaults then the debt becomes Samuel Fleet's.

While there is insufficient evidence to determine exactly the role of Haule in all these transactions, it would appear that he was involved in the money market and was acting as a proto-banker from time to time. It is known that attorneys in this period were concerned with financial affairs and, although there is no evidence of money being deposited with Haule as an investment, he is clearly acting as a go-between with his clients on one side and certain specific persons on the other. Thus one, Robert Monoxe of Wouldham, is the provider of funds on four occasions in 1591; Wigan Burston, apparently of London, appears four times in 1594-95; John Baker and Thomas Parker also of London are found during the same period and in 1594, Mistress Catherine Wrott lends money on bond on three occasions. It is also interesting to note that in most cases, except that of Monoxe, the payment is to be made at well defined places in London such as the Royal Exchange, the Temple Hall or Church or the houses of John Baker in Coleman Street or of Mr Chambers in St. Paul's Churchyard. The link with early banking is possibly made the more likely when one realises that Mr Chambers is designated goldsmith.

There is also a somewhat curious change in the face value of bonds entered into during the five years covered by the accounts. In 1591, a total sume of 523li. was involved and in 1592 this had slumped to a mere 160li. while the following year no bonds are recorded at all. In contrast, in 1594 the gross sum was 1830li. and in 1595, 1220li. There is also a corresponding rise in the actual sums being lent. One must not make too much of this for we are dealing with very few entries and the sums vary considerably over the entire period, but whereas in 1591-92 the largest bond is for 160li. and this sum is only recorded twice, in 1594-95 a sum of 200li. or more is recorded on eight occasions, half of these being for 400li. It could be said that as the years pass Haule becomes more involved rather than less in financial affairs and in the provision of ready money.

There is usually no indication of interest being paid, though the law against usury had been repealed in 1571, but it is quite evident that Haule was concerned with such affairs for his own profit. It has already been noted that the word 'pawn' is used on at least one occasion and it would not be realistic to imagine that money was lent in large or small amounts without some form of security being taken. This, of course, partly accounts for the bonds already discussed for the sum bound was normally twice that actually involved as was shown in the case of Jeremy Fleete with a bond of 401i. for which a payment of 201i. was anticipated. A very special case occurs in 1595, when on 4th October Henry Haule with his brother Thomas entered into a bond in 2001i., with their uncle, Christopher Dering. Normally this would indicate a repayment of 1001i. to clear the loan, but in fact the stipulation is for a repayment of 1301i. after three months warning. Then follows a significant clause: 'and in the meantime to pay therefore after the rate of 81i.. per annum'.

Does this indicate an annual rate of interest of 4 per cent? Unfortunately the only other information given is that a year later Haule paid 60li. upon the bond. The most detailed single picture of a transaction or, rather, series of transactions of this kind occurs with Arthur Barham of Maidstone. It has already been noted that Haule acquired both Digons and Chillington Manor in Maidstone from this family and, indeed, the whole of pp. 41-7 in the accounts is taken up with a list of monies lent to Barham and of attempts to recoup these sums. References to this family continue throughout the notes, but the detail given suggests that

Arthur Barham not only used Haule as a source of ready cash, he was also very deeply in debt to him. On pp. 41-4 no fewer than thirty-four entries are recorded, which indicate that Barham was indebted to Haule in the sum of 129li., and on the following three pages there are not only more entries regarding money lent but also references to the pawning of Arras tapestry, the sale of various hangings and also the sale of virginals to Haule. On another occasion Barham received 5li. 'for goods in his great house' though a note also adds that Haule was recompensed in land; and one entry reads that 40s. was lent 'for his ringese' which sounds like another instance of pawning valuables. In 1593, Barham received 51li. for tapestries and also 100li. for New Warke Medes. Repayment is clearly in kind as well as money and, while these accounts and notes do not include any reference to the acquisition of Digons or Chillington, one can see how easily the attorney obtained an interest in property. Boley Hill House, Rochester, the property of the Badcocke family, was the subject of a rent-charge in 1593 and it appears that for a sum of 20li. lent Haule obtained an annual rent of 40s, which will have given him a direct interest in the property.

(iii) The Middle Temple

One of the special interests residing in this volume is that it offers some detail of Henry Haule's connection with the Middle Temple. This information cannot be isolated from the remainder of the book without doing violence to the whole, for it lies interspersed among the other entries. First, there are pp. 25-8 on which is a statement of his disbursements at London during his readership in 1595. This is a straightforward account and requires no comment, except that it confirms once again the importance of the Thames as the highway from Kent to London. The second set of entries occurs on pp. 83-6 and relate to the provision of bucks during the same term of office. Once again these entries call for little comment: they give the name of the provider, the number of bucks to be provided and a note of the quality of the same and the sum, usually 10s., paid to the messenger who brought the buck. Among those listed as providing bucks are members of the Barnard, Boys, Broadnax, Bufkyn, Dering, Finch, Moile, Manwood, Rivers, Scott, Strude, Twysden and Waldron families, all having Kentish connections; and other names of some interest are Laurence Washington, Raulfe Sheldon, John Shurley and Edward Bacon. The third group of references to the Middle Temple is found scattered throughout the volume, though mainly near the end of the entries and these include a bill for the purchase of 'Muscadell' and payments to the steward for Haule's commons.

(iv) Miscellaneous items

On pages 1, 108-9 and 117 of the book there are medicinal recipes and also on p. 112 there are references to the making of gifts to Mrs. Elizabeth Scott and to Mrs. Burston. In September 1594, an entry records the payment of 10s. as wages to his cook, Agnes, and in October 1593 Haule lent 'The Commentaries of Fraunce' to the Rev. R. Chambers, the minister of Loose. The final entry in Henry Haule's hand is a note of the birth of his son George on the 19th December, 1591, three days before the death of his father, also George. It is of interest to note that the baptism of the child which took place on 28th December was witnessed by Anthony Dering, Margaret Dering, Lady Elizabeth Goulding




Fig. 3. Copy of a map showing the position of Caringes and Perryfield in Maidstone, reproduced from Archaeologia Cantiana, i (1858), 155.

and William Twysden. These are, however, only a few entries taken out of their context because they relate to matters other than the legal profession or the provision of financial assistance.


One particular topographical puzzle is raised by this volume for on p. 2 Haule refers to the Letters Patent granted to Thomas Hendle of Otham in July 1530 of 40 acres of land in Maidstone next to the chapel of St. Anne. 21 Other entries indicate that this land consisted of two plots called Perryfield and Carings. All this property belonged to Boxley Abbey before the Dissolution. The only evidence still apparent in Maidstone is the name Perryfield Street lying to the north-east of Sandling Road (the A229), but in an area developed during the nineteenth century. St. Anne's chapel, itself, is obscure: the information given by Haule is imprecise and a single reference by Hasted somewhat cryptic; 22 but if this medieval shrine was adjacent to Perryfield and Carings, then at least the approximate location can be suggested.

In the first volume of Archaeologia Cantiana there is an article by Beale Poste regarding the Roman settlement Vagniacae, which he erroneously indentified with the Springfield area of Maidstone. 23 This article, however, includes a map showing that in the early nineteenth century Perryfield was a tract of land lying north-east of the Sandling Road and north of the boundary of the new gaol; while Carings lay on the other side of the main road and included the area occupied by Maidstone East Station as far as the old barracks. Carings Stile, on the banks of the Medway, appears to be at the riverside end of the footpath which separates Brenchley Gardens from the railway.

This suggests that St. Anne's chapel lay somewhere in the area bounded by Brenchley Gardens, Springfield Mill and the streets lying north-east of the A229 as far as the gaol boundary. But in a sense this only confuses the issue still more for Carings was adjacent not only to Chillington Manor which Haule acquired from the Barham family, but also to St. Faith's Green, an area which proved a constant bone of contention between the Corporation and the owners of the manor. It seems possible, therefore, that St. Anne's may have been close to the site of medieval St. Faith's church and that, whatever the grant of 1536 to Thomas Hendley implied, St. Anne's was already a ruin or even a lost site, possibly indeed the very cause of the litigation between Haule and the borough which is revealed in the Burghmote records. ²⁴

George Haule's Diary

Pp. 25, 28-34 and 129-176 are taken up with notes kept by George Haule between 1644 and 1650 of recognizances and some other business as justice of the peace. The problem of authorship has already been referred to; certainly George first appears on the Commission in 1644 but the sudden cessation of entries in 1650 is by no means a sure sign that this is the work of Henry's grandson rather than his son. The significance of these notes lies in the complete lack of records for the county Quarter Sessions during the years in question, and it is to have been wished that Haule had kept a fuller account of all his duties in this respect. He records over 100 cases which were heard during these years of uncertainty including a few which went to the Assizes. The majority of entries, however, relate to the West Kent Sessions held at Maidstone and, in view of Haule's association with the county town, most of the cases are related to nearby parishes. Very few concern Maidstone itself, which was a Quarter Sessions

borough in its own right. Thus the great majority of entries relate to an area bounded by West Malling, Northfleet, Hoo, Gillingham, Hucking, Lenham, Sutton Valence and Linton, though a few are for parishes further afield. Of these cases many are simply recognizances to keep the peace and there are a substantial number for appearances to prefer an indictment or to give evidence. The matters cited include larceny and the theft of poultry, the taking of game and sheep stealing. A few concern public morals, the desertion of a family or the detaining of wages and five relate to bastardy, once with an examination added. These entries are all as one might expect. The form is standard throughout, but there is some evidence to suggest a measure of difficulty for the justice in determining to whom the persons cited are to be bound at a time when the king is hardly personna grata.

It is also to be noted that there is a significant gap in the record from 19th February, 1647/8, until 8th August of the same year. The second Civil War took place between May and September 1648: the battle of Maidstone was on 1st June.

Part I: Receipt of Fines, etc., 1590-95 (pp. 1-28)

Note: This part of the book contains three elements: pp. 1 and 2, a title page used to write down a recipe and for other memoranda, and also notes regarding land near St. Anne's chapel, Maidstone; pp. 3-24, a list of monies received, either from individuals or on account of law suits; pp. 25-28, comprising (a) p. 25, entries regarding the provision of bucks and an entry in the hand of George Haule (see Part III, below, p. 57); (b) p. 26, which is blank; and (c) pp. 27-8, 'charges disbursed about my readinge at London August anno 1595'.

The unusual entries, i.e. pp. 1 and 2 and pp. 27-8, are given in full with editorial comment where necessary. Pp. 3-25, however, are in a standard form which normally reads: 'de or of X....ys' or, alternatively 'de X versus Y....zs.' Haule uses Latin and English indiscriminately and very occasionally French and he also apparently distinguishes Mro (Magistro or Master), Mr (Mister) and Mris (Mistress), and occasionally Mra (Magistra for Mistress), but whether there is really any difference in his mind between the first two is debatable. He normally indicates the date by reference to the legal term and regnal year. In the version given below only personal names and the amounts of fee are noted, unless some exceptional detail appears in the original. Dates throughout have been modernised and regnal years omitted. So far as possible different hands have been identified and the word *Holograph* in square brackets indicates an entry in any hand other than Henry Haule's.

George Haule, my revered and much loved father died on 19 December 1591, about the hour of six in the afternoon in the 8lst year of his age and was buried in the southern corner of the parish church of Wye next to the tomb of Dorothee my first wife.

Part III: George Haule - Diary of Recognizances, 1644-50 (pp. 25, 28-34, 129-77).

Note: This part of the volume is essentially a list of recognizances taken before George Haule as justice of the peace. Nearly all are for Quarter Sessions, but occasionally Assize cases are included. Other matters of court business are found on pp. 25, 30, 32, 130 and 176, and these entries include two examinations. The whole section, however, is almost exclusively in one standard form of document which can be described as (a) the name of the person bound with a form of words indicating the liability (either tenetur domini Regis in, or, 'you shall acknowledge towards our sovereign lord the king in'), plus a sum of money; (b) the names of the sureties similarly bound, each in half the first sum mentioned; and (c) the condition. In this edited version the obligation clause in English or Latin is usually omitted except for the first entires and those after February 1648/9 when, with the execution of Charles I, the form changes. Normally, the condition is given in full though spelling is modernised. In many instances a marginal note has been added, either, non sol or non soll, presumably an abbreviation for non solutus, not surrendered.
