# SOME TITLE DEEDS AND OTHER DOCUMENTS RELATING TO PROPERTY IN SHIPBOURNE PARISH, 1423-1823

EDITED BY C. W. CHALKLIN

#### Introduction

These documents concern some small fields and houses in Shipbourne, near the Green, particularly two acres called Spelcroft. In comparison with eighteenth-and nineteenth-century title deeds, medieval deeds are rare, those of the sixteenth century relatively scarce, and seventeenth-century documents less common. It is unusual to be able to trace archival evidence for little properties from the early fifteenth century onwards.

While wills have recently attracted much attention from historians, the value of deeds has been less appreciated. This applies especially to rural documents. Huge numbers have survived for Kent, partly because the land was mostly freehold, partly because its ownership was greatly divided, at least before the nineteenth century. Besides a brief reference to the property, they record owners, their residence and occupation; adjoining properties are usually mentioned, and sometimes the names of occupiers. Signatures and sometimes surviving seals are found at the end, and the signatures of witnesses are endorsed. The majority of the population, especially women, were unable to write in the sixteenth and early seventeenth centuries, so that 'marks' are frequent. If the properties are sold or mortgaged, sums of money are stated. Leases, except leases for a year in combination with releases, rarely survive because their legal value disappeared at the end of the term.

Deeds are parchment, and become gradually longer with more legal detail, so that one sheet is common in the sixteenth century and two or three in the eighteenth century. Grants, and feoffments, that is conveyances by 'livery of seisin' (or delivery of possession) are normal before about 1650. Then leases and releases on successive dates become usual in the eighteenth century; in this case the first is a lease for a year granting possession at a nominal sum, a shorter version, and the second a release giving the interest, with full details. Bundles of deeds proving ownership include wills, or extracts of wills, relating to the property. The deeds are sometimes accompanied by bonds in twice the amount of the purchase price, which is thus guaranteed. To protect ownership the conveyance is often registered by the Court of Common Pleas in the form of an agreement following a fictitious suit, the defendant (the vendor) being said to levy a fine, acknowledging the right of the plaintiff (the purchaser) to the property, which is described in approximate terms, with an approximate price; one copy was given to the purchaser and is typically found with the deed. Deeds sometimes include covenants to levy a fine, mentioning the parties, the property

and its intended formal description in the fine. While a bundle of deeds is particularly concerned with one or more properties, others are mentioned in some deeds, and naturally in wills, which are given in full. Fines and covenants to levy a fine are often found for two or three conveyances, to save expense.

The deed of 1423 is in the Centre for Kentish Studies collection classified as U442, assembled from solicitors' offices and private owners by the Sevenoaks antiquary, Dr Gordon Ward, and presented to the Kent Archaeological Society in 1954. The deeds relating to Spelcroft are from U55, collected similarly by the solicitor and historian, H. W. Knocker. The deeds labelled 'Martins', presumably from Martins Farm in Shipbourne, are owned privately and were studied while in the possession of Mr Sydney Simmons, the historian of Tonbridge Castle and Tonbridge Town Lands. The three earliest deeds in this bundle concern Spelcroft and may be strays from the Knocker bundle. The seventeenth and early eighteenth-century documents were prepared by members of the Hooper family, attorneys and scriveners in the neighbouring market town of Tonbridge.

Spelcroft lay south of Nether Street, running from a junction with the Tonbridge-Ightham road near Shipbourne Church eastwards to Claygate, near the eastern corner of the Green (see Fig. 3). Stallands or 'Stonelands' field (2½ acres) adjoined the road. Spelcroft was on its southern boundary with access to the road on its west side. The house called Longs lay on the north-east side of the Green. Among other properties Bouchers *alias* Reeves was to the north of Nether Street and on the south of the Green. The house called Pike Hill and the little hemp-plot (in the deed of 18 April 1710) were at Stumbles Hill by the Tonbridge-Ightham road.

Spelcroft and the other properties were owned by local farmers, and master craftsmen and tradesmen who were sometimes also farming. The description of the owners of Spelcroft as 'husbandmen' suggests that they were smallholders, compared with larger farmers or 'yeomen'. Building in brick was clearly becoming usual by the end of the seventeenth century. Holders of property made wills and were about a quarter or one third of the inhabitants. It was common for some owners to hold several fields and houses in the same district, to let or mortgage some or all of them, and to rent farms, as did Robert Wamsley (died 1573). Property was sometimes owned by families for 100 or 200 years, as was the case of Spelcroft and Stallands. Among apparent causes of selling were migration from the area and joint ownership by heirs, as in the deed of 16 January 1657/58. Property values are of great interest, the steady prices of the later seventeenth and early eighteenth centuries being noticeable. Field names often continue for centuries; sometimes a change of owner may alter the name, as shown in the deed of 16 January 1657/8.

The historical significance of title deeds is increased by the study of other documents related to the owners, such as parish registers, wills kept in the records of the ecclesiastical courts, and probate inventories. Some relevant documents are calendared in the Appendix. Wills may refer to the family, the distribution of personal estate, property owned and leases and mortgages. Inventories describe and value personal estate such as household goods in their rooms, working tools and materials, and crops and livestock. The main series of Rochester Consistory and Archdeaconry probate inventories begins in 1687, and the inventory of 1573, found with the original will, is a chance survival which may be unique among the wills.

#### Bequests

To Jane daughter of Nicholas her son, deceased, £40, which Nicholas by will 17 September 1658 bequeathed to her, to be paid within two years of his son John becoming 21, out of lands called Benedicts and Gouldings *alias* the George Lands in Sevenoaks.

To Margaret daughter of Nicholas these lands charged with £40 according to Nicholas's will; as the lands were bought in her name with Nicholas's money, they are bequeathed according to his will [as above].

To Elizabeth daughter of Nicholas a parcel called Spelcroft comprising two acres in Shipbourne bought from John Wamesley, which Nicholas desired her to convey to her; bought with Nicholas's money in her name.

To Sara her goddaughter, wife of John Crosfield, 5 shillings, and to the maidservant attending at her death 5 shillings within a short time after she dies.

To Joane her grandchild, daughter of Nicholas, a silver spoon and a pair of sheets.

To Margaret Brattle, her grandchild, a pair of sheets.

To Alice Saxby, her grandchild, her wedding ring, silver spoon, two pairs of sheets.

To Grace Brattle, her grandchild, a black gown, 'groegreene' petticoat and the rest of her woollen and linen apparel.

To Nicholas Brattle, her grandchild, a little messuage or tenement late occupied Rebecca Feild now William Webb, anciently the Goodwyns, and a garden, backside and orchard bought with divers other tenements from John, Richard and Thomas Goodwin in Shipbourne.

To John Brattle and William and Stephen Saxby her grandchildren equally one messuage or tenement occupied by James Wellard called Bowchers *alias* Reeves, and  $1\frac{1}{2}$  acres, and  $2\frac{1}{2}$  acres called Stallands *alias* Stonelands and freehold lands in Shipbourne.

To her granddaughter Alice her Bible, brass and pewter.

To John Brattle, her grandson, her silver bowl, cupboard, table with a frame and form, and two bloom andirons in the hall of her house; and her carpet and a joined chest wherein is set the first two letters of his grandfather's name.

John Brattle and William and Stephen Saxby to be her executors; the rest of her personal estate to be used to settle her debts, pay her funeral charges and the testamentary probate costs.

To Thomas his son £10 when he is 20

To William his son £10 when he is 20

To Margaret, and Anne his daughters £20 each when they are 21 or on marriage, whichever is the sooner

To Thomas a cupboard and a pair of andirons in the hall of his house at Shipbourne

To William, Margaret and Anne a silver spoon each

To Thomas, William, Margaret and Anne two chests, one joined and one plain, each

To Margaret his wife the linen and the rest of his personal estate, for her use while she is a widow, to be shared by her equally among the children at her discretion

To Margaret his wife the east end of the house (hall and rooms, chambers and garrets) and the woodhouse and orchard he occupies, as long as she is a widow; if she dies or remarries, to Anne his daughter 20 shillings, to be paid by Thomas until she is 18, with the right to distrain if unpaid

To Thomas his son the house he occupies and four parcels of six acres, of which three were occupied by himself and the fourth (Spellcroft of two acres) was held by Thomas Denton, all in Shipbourne; if Thomas sells, then £20 each to William, Margaret his sister and Anne; he can make a jointure or settlement in marriage on a wife

To Margaret his daughter, then if deceased to William his son, a messuage with garden and backside in two parts, occupied Jonathan Long and Widow Sharley, in Tonbridge town

To William his son two messuages adjoining the last mentioned messuage, with stables, outhouses, buildings, closes, yards, backsides, gardens and orchards occupied Mr Timothy Stileman and John Barnaby, in Tonbridge town; out of it William is to pay a £5 annuity to his widow, with the right to distrain if unpaid; if William sells the two messuages left to him, then he is to pay Thomas, Margaret his sister and Anne £20 each; he can make a jointure or settlement in marriage on a wife

Executors and Overseers Margaret his wife, Thomas his son and Margaret his daughter to be executors; his friends William Busse and Thomas Denton to be overseers, their costs being paid by the executors

Witnessed Alice Page [her mark], Anne Rumings [her mark], Thomas Stileman

Stephen Fremlyn died in April 1743 without altering the said will giving all his estate to Collins, who supposed the testator might revoke the deeds of 1717 above mentioned in regard the settlement is voluntary; the will was declared by the testator to be his last will in the presence of three witnesses, and it was executed by him in their presence.

[In another hand] the will 'was executed as the law directs'; by it the estate is devised to William Collins without any limitation to his heirs or otherwise; he is given the inheritance so that if he dies his heirs may pay the annuities, a life interest being insufficient for this purpose; he takes the fee simple, and is entitled to the surplus of the testator's personal estate.


