KENT FEET OF FINES

for 7 Edward III onwards [1333-1377]

These abstracts have been started at number 251 following on from *Archaeologia Cantiana* volume 20 for 1893 with number 250 being printed on page 186. The abstracts have been checked back against the originals which are at The National Archives. The court copy the feet are bound in little red books of 25 fines, and the modern call numbers are given for the books. The fines are numbered on the reverse using a metal die stamp. The fines for Divers Counties for the period covered by *Archaeologia Cantiana* are given at the beginning and subsequent ones in the appropriate places. The files of unknown counties will be examined at the end of the series for Kent places.

Warwickshire and Kent

(35) Westminster. In the octave of Holy Trinity 3 Edward III

Q: Giles Beauchamp (*de Bello Campo*) and wife Katherine.

D: Henry de Hambury.

The manor of Alyncestre with appurtenances in the county of Warwickshire; and one messuage, 92 acres land, 10 acres wood, 20s rent and rent of 12 hens and one fifth part of one mill in Estwicham, Bixle, Plumpstede and Wolewyche in the county of Kent. To hold to Giles and Katherine and the heirs of their bodies of the chief lords of that fee for the services appertaining. Remainder to the heirs of Giles.

Kent and Hampshire

(38) Westminster: From Saint John Baptist in 15 days 3 Edward III and afterwards in the octave of Michaelmas 4 Edward III

Q: William de Clynton and wife Juliana.

D: Martin Eschebaud and Walter de Leghton

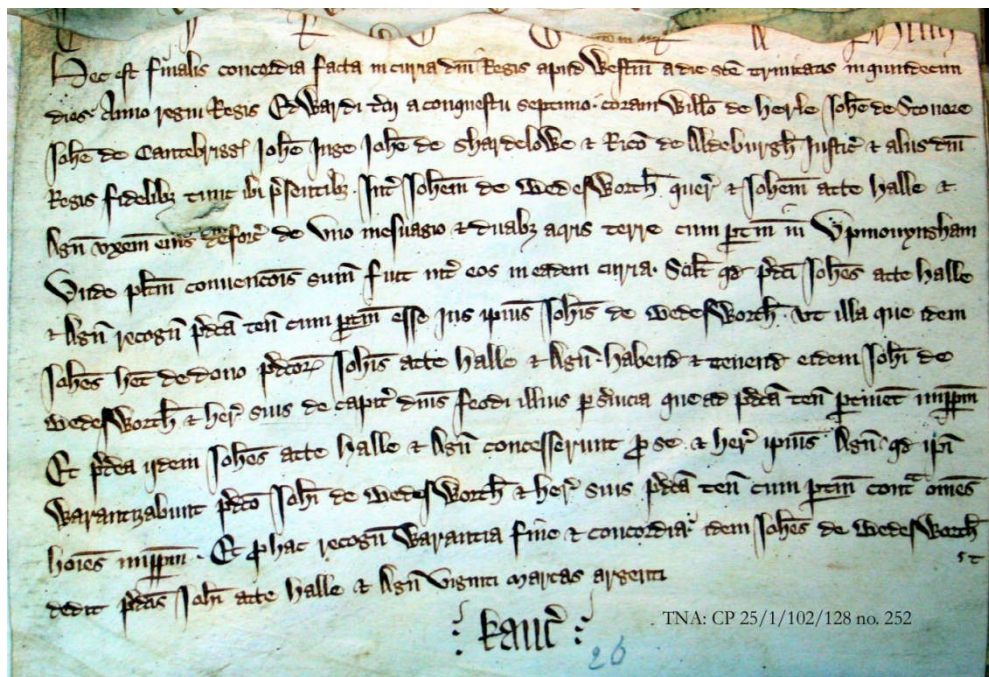

One messuage and 5 acres of land in Recolure [Reculver]. To hold to Robert and Joan and the heirs of the body of Robert. Remainder to (1) Sarah daughter of Robert Chakbon and the heirs of her body (2) the heirs of Joan. To hold of the chief lords of that fee for the services that pertain to the aforesaid tenement in perpetuity.



(252) Westminster: From Holy Trinity in 15 days 7 Edward III.

Q: John de Bedesworth.

D: John atte Halle and wife Agnes.

One messuage and 2 acres of land in Upmonynsham [Great Mongeham⁹]. To hold to John de Bedesworth and his heirs. To warrant from John and Agnes against all men. John de Bedesworth gave 20 marks.

(253) Westminster: From Holy Trinity in 15 days 7 Edward III.

Q: Walter le Beuer of London and wife Joan.

D: Henry Beauflour of London.

28 acres of land in Shelke [Chalke by Gravesend] and Shorne. To hold to Walter and Joan for the lives of Henry and his heirs paying yearly one rose at the Nativity of Saint John the Baptist and doing all service due to the lord of the fee. Reversion to Henry and his heirs. To hold of the chief lords of that fee for the services that pertain to the aforesaid tenement in perpetuity.

(254) Westminster: On the morrow of the Ascension of the Lord 7 Edward III, and afterwards on the morrow of Saint John the Baptist 7 Edward III.

Q: Geoffrey de Rutone and wife Joan.

D: Richard de Rutone.

One messuage, one mill, 97 acres of land, 8 acres of meadow, 8 acres of wood, rent of 40s. 4d, 2 capons and 22 hens, 145 eggs in Westwell and Hothfelde. To hold to Geoffrey and Joan and the heirs of their bodies. Remainder to the heirs of Joan. To hold of the chief lords of that fee for the services that pertain to the aforesaid tenement in perpetuity.

(255) Westminster: From Easter in one month 7 Edward III and afterwards on the morrow of Saint John the Baptist 7 Edward III.

Q: William Brembel of Wy.

D: William son of William Brembel of Wy and wife Isabel.

One messuage, 24 acres of land, 6 acres of meadow, 4 acres of pasture, 2 acres of wood and 3s. 6d. rent in Wy, Godmersham and Esshetesford. To hold to William son of William and Isabel and the heirs of their bodies of William and his heirs, paying yearly 100s., half at Michaelmas and half at Easter and doing all services due to the chief lords of that fee. Reversion to William and his heirs.

One messuage, 24 acres of land and 2 acres of meadow in Herne. To hold to John and his heirs. To warrant from Richard and Cicely and the heirs of Cicely. John gave 20 marks.

(258) Westminster: In the octave of Saint Michael 5 Edward III and afterwards from Holy Trinity in 15 days 7 Edward III.

Q: Michael de Heure and wife Catherine.

D: William de Reculture and wife Mary.

One messuage in Maydenestane. Held for life by Alice late wife of John Breton of the inheritance of Mary. To hold after Alice's death to Michael and Catherine and the heirs of Michael. To warrant from the heirs of Mary against all men. Michael and Catherine gave 20 marks.

(259) Westminster: From Holy Trinity in 15 days 7 Edward III.

Q: John Elys of Demechyrche.

D: William son of Walter Elys and wife Lettice.

One messuage and 18½ acres of land in Demechyrche next Romene. To hold to John and his heirs. To warrant from the heirs of Lettice against all men. John gave 20 marks.

(260) Westminster: From Easter in 15 days 7 Edward III and afterwards in the octave of Holy Trinity 7 Edward III.

Q: John atte Lee.

D: John Moton and wife Joan.

One messuage and 18 acres of land in Eastry. To hold to John atte Lee and his heirs. To warrant from the heirs of Joan against all men. John atte Lee gave 20 marks.

(261) Westminster: From Easter in 15 days 7 Edward III afterwards in the octave of Holy Trinity 7 Edward III.

Q: Stephen Braunche.

D: Thomas le Barber of Upmonyngham senior and wife Beatrice.

One messuage in Upmonyngham [Great Mongeham]. Plea of warrant of charter. To hold to Stephen and his heirs. To warrant from the heirs of Beatrice against all men. Stephen gave 10 marks.

(262) Westminster: From Easter in 15 days 7 Edward III and afterwards in the octave of Holy Trinity 7 Edward III.

Q: Hugh de Lee and wife Lettice.

D: Hamo Caluel of Grenewych.

One messuage, 230 acres of land, 10 acres of meadow, 8 acres of wood, 20s. rent in Lee, Eltham and Ketebrok [Kidbrook]. To hold to Hugh and Lettice for their lives. Remainder (1) to Simon son of Hugh and wife Sybil and the heirs of their bodies (2) to the heirs of Hugh.

(265) Westminster: On the morrow of Saint John the Baptist 7 Edward III and afterwards at York: from Michaelmas in one month 7 Edward III.

Q: Robert le Vineter and wife Alice.

D: Christian Tannere of Maydenstan and wife Joan.

Three messuages, 4 acres of land, 3 roods of wood and 5¼d. rent in Maydenstan. To hold to Robert and Alice and the heirs of Robert. To warrant against the heirs of Christian. Robert and Alice gave 20 marks.

(266) Westminster: From Saint John the Baptist in 15 days 7 Edward III and afterwards at York from the morrow of Saint Martin 7 Edward III.

Q: Roger de Northwode and wife Elizabeth.

D: John de Bykenore senior.

One messuage, 437 acres of land, 75 acres of pasture, 155 acres of wood, rent of 40s., 7 cocks, 40 hens and 2000 eggs in Bykenore and Holyngburne. To hold to John for life, of Roger and Elizabeth and the heirs of Elizabeth paying yearly to Roger and Elizabeth and the heirs of Elizabeth a rose at the nativity of Saint John the Baptist and doing service due to the chief lords of the fee. Reversion to Roger and Elizabeth and the heirs of Elizabeth.

(267) York: From Michaelmas in three weeks 7 Edward III.

D: John de Saint Paul and John de Tyddeswell.

The manor of Foxgrove¹⁰, one messuage, three carucates of land, 14 acres of meadow, 38 acres of wood, 29s. ½d. rent in Beghenham [Beckenham]. To hold to Master Henry for life. Remainder to (1) Henry son of John de Clif and the heirs male of his body. (2) Hugh son of John de Balne and the heirs male of his body. (3) the heirs of Master Henry.

(268) Westminster: From Holy Trinity in 15 days 7 Edward III and afterwards at York: From Michaelmas in 15 days.

Q: Stephen atte Pyrie of Renham.

D: John le Hert and wife Joan.

One and half acres of land in Renham. To hold to Stephen and his heirs. To warrant against the heirs of Joan. Stephen gave 40s.

¹⁰ Edward Hasted, *The History and Topographical Survey of the County of Kent*: Volume 1 (1797), p. 528; "FOXGROVE is a manor in this parish, [Beckenham] which had anciently owners of that surname, as appears by the Book of Aids, in the 20th year of king Edward III. in which the heirs of John de Rokeley and John de Foxgrove accounted for it as half a knight's fee. To which family succeeded Bartholomew de Burghersh, a man of great eminency in those times, who possessed this manor at his decease, in the 29th year of king Edward III. leaving Bartholomew his son and heir; Henry, a younger son, and one daughter, named Joan."

D: Thomas de Embroke and wife Eleanor.

One messuage, 116 acres of land, 68 acres of pasture, 18 acres of wood, 52s. 10½d. rent and rent of 7 cocks, 56 hens, 458 eggs in Swynefelde. Quitclaim from Thomas and Eleanor and the heirs of Eleanor to John and his heirs. To warrant against the heirs of Eleanor. John gave £100.

(270) Westminster: From Saint John the Baptist in 15 days 7 Edward III and afterwards at York: on the morrow of All Souls 7 Edward III.

Q: John Savage and wife Alice.

D: John de Tenham, chaplain.

Three messuages, 13 acres and 1 rood of land in Tenham and Lyndestede. To hold to John and Alice and the heirs of their bodies. Remainder to the heirs of Alice.

(271) Westminster: From Saint John the Baptist in 15 days 7 Edward III and afterwards at York: on the morrow of All Souls 7 Edward III.

Q: John de Gustone and wife Christine.

D: William Loterich and John de Twitham.

Manor of Flete Botelers [Butlers Fleet in Ash next Sandwich]. To hold to John and Christine and the heirs of Christine. Remainder (1) John son of John de Gustone and the heirs of his body (2) to John son of Alan de Twitham and his heirs.

(272) Westminster: From Saint John the Baptist in 15 days 7 Edward III and afterwards at York: From Michaelmas in one month 7 Edward III.

Q: Ralph le Sauvage and wife Laura.

D: William Peverel.

The manors of Halsted¹¹ La Corye and La Hewette¹², one mill, 40 acres of land, 3 acres of meadow, rent of 14s, and 2 geese, 4 cocks, 17 hens and 200 eggs in Eastbarmlynge [East Barming] and Shorham. To hold to Ralph and Laura and the heirs of their bodies. Remainder to the heirs of Laura.

(273) Westminster: From Holy Trinity in 15 days 7 Edward III and afterwards at York from Michaelmas in 15 days 7 Edward III.

Q: Philip de Castwisle¹³.

D: John de Castwisle and wife Joan.

Edward Hasted, *The History and Topographical Survey of the County of Kent*: Volume 3 (1797) p. 14; "William de Malevill was in possession of this estate in the reign of king Henry III. as appears by the escheat-rolls; soon after which it came into the family of Chellesfield. In king Edward III's reign it was owned by Ralph Savage, whose widow, Lora, heir of Reginald de Preston, paid aid for it in the 20th year of that reign, as half a knight's fee, which William de Chellesfield before held in Halsted and Preston of the archbishop."

¹² Dr. Paul Cullen comments "La Corye can be identified with Curry Farm (TQ 4860) in Halstead. This is a nice find, as I haven't got many early spellings for the name. It appears in the bounds of Knockholt parish in 1463 (Corychalk felde, Cory Chapell, the Priours Wode which was callyd Cory Yokys and nowe Wardebras Wode) and in the Halstead tithe award in 1840 (Currey field, Part of Curry field, Curry Wood). La Hewette is Hewitts (TQ 4863) in Chelsfield (PNK p.16)."

(274) Westminster: From Holy Trinity in 15 days 7 Edward III and afterwards at York from Michaelmas in 15 days 7 Edward III.

Q: William de Patyndenne.

D: Isolde de Patyndenne.

30 acres of land, 3 acres of meadow in Merdenne. To hold to Isolde for life, of William and his heirs, paying yearly a rose at the Nativity of Saint John the Baptist and doing all services due to the chief lord of that fee. Reversion to William and his heirs.

(275) Westminster: In the octave of Holy Trinity 7 Edward III and afterwards at York from the octave of Michaelmas 7 Edward III.

Q: John Ketel and wife Alice.

D: Thomas Stidulf.

Two messuages, 54 acres of land, 2 acres of meadow and 4 acres of wood, 4s. 8½d. rent and rent of a cock, 8 hens and 8 eggs in Wrotham and Heggham [Ightham]. To hold to John and Alice and the heirs of their bodies. Remainder to the heirs of Alice.

23 acres of land, 2 acres of wood, rent of 20s., 25 hens and half of one messuage in Tenham and Lodenham. To hold to John and Alice for their lives. Remainder (1) to John son of Alice and wife Joan and heirs of the bodies of John and Joan, (2) to the heirs of Alice.

One messuage, 44 acres of land, 4 acres of meadow, 2 acres of wood, 5s. 10d. rent and the rent of a hen in Egertone and Boctone.¹⁵ To hold to John Marberer and Bennet and the heirs of their bodies. Remainder to the heirs of Bennet.

8½ acres of land in Lyttlebourne and Welle.¹⁷ To hold to Thomas and his heirs. Warrant against the heirs of Alice. Thomas gave 20 marks.

in the Fine were for ever barred. The statute *de donis condicionalibus* specifically prevented a Fine from barring an estate tail, by which we may assume that attempts had been made so to use it." Those holding land in fee simple who were disseised and who were then subject to a fine and proclamation, or those who otherwise felt they had a right to the land comprised in the fine were obliged to assert their claim. There were anciently four methods of claiming, (1) by action (2) by entering such claim on the record at the foot of the fine in the courts possession, on the dorse, with the name of the counter claimant and the words *apponit clamium suum* (3) by entry on the lands (4) by continual claim. By the statute of non claim, 34 Edward III c. 16 this barring effect of a fine was abolished; "The Plea of Non Claim of Fines which from henceforth be to be levied shall not be taken nor holden for any bar in time to come." By 1 Richard III c. 7 and 4 Henry VII c. 24 barring was again restored, though the time of the claim was extended. But the second method of claim above was not in force after the statute of Henry VII. (H. J. Stephen, *New Commentaries on the Laws of England* (1841) p. 520-21.) I would add that I have not come across these claims on the dorse of the fines in Richard II, Henry IV and Henry V.
